ASSUMPTION OF RISK

For participation with High Desert River Outfitters



Section 1

A . The risk of injury from the activities involved in a High Desert River Outfitters (hereafter referred to as . HDRO .) river rafting trip is significant, including the potential for permanent paralysis and death, and while particular skills, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and I understand that,

B . Damage to or loss of property, personal injury or fatality may occur due to the capsize of a raft, kayak or other water craft, collision of a raft, kayak or other vessel with a vehicle, bridge, other water craft, rock, log, tree, or other object in the river or on shore. Damage to or loss of property, personal injury or fatality may occur due to falling into or from a raft, kayak or water craft, prolonged submersion in water, or falling while hiking or walking on shore on and/or off established trails and paths. Damage to personal property may occur due to leaking or improperly sealed bags or containers. Damage to or loss of property, personal injury or fatality may occur due to immersion in cold water and hypothermia (significant loss of body heat), entrapment in or under the water due to a rock, tree, water craft, loose equipment, river current or other object in the water, collision while swimming in swift or calm water with a rock, tree, water craft or other man-made or natural object in the water or on shore. Damage to or loss of property, personal injury, illness or fatality may also occur due to the presence of water-borne parasites, bacteria or pollutants and/or exposure to temperature extremes, solar radiation or inclement weather. Damage to or loss of property, personal injury or fatality may also occur due to vehicle accident while riding in vehicles operated by HDRO , its agents, employee or associates. Furthermore, I understand that advanced medical care, medical facilities, and the availability of physicians and/or nurses, in the event of an accident or illness in remote places may be absent or substantially delayed. I understand that HDRO does not carry satellite phones or radios and that cellular service is rarely available in the areas where HDRO operates and that immediate communication with advanced medical personnel and/or government authorities is rarely possible; and,

C . In consideration of and as part of payment for the right to participate in HDRO trips or tours and the services and food arranged for me by HDRO and its agents and associates, I certify that I have the necessary skills and ability to participate in this activity, and do voluntarily participate in this river trip and the related activities with knowledge of the dangers and risks involved, both known and unknown. By my signature below, I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, BOTH KNOWN AND UNKNOWN AND ASSUME FULL RESPONSIBILITY FOR MY PARTICIPATION; AND, I accept and assume responsibility for myself for injury, death and loss of or damage to personal property and expenses thereof as a result of my willful & wanton participating in this activity except to the extent such damage or injury may be due to the negligence of HDRO. I hereby agree to assume all responsibility for myself and my property and hereby release and discharge HDRO and its officers, directors, stockholders, employees, representatives, sub contractors and agents from all claims, demands, and rights or causes of action for injuries or damages of any description which may occur as a result of my participation on this HDRO trip.

Section 2

A . HDRO and/or its associates and employees act only as agents for the client in making arrangements for trips and/or travel services with common carriers or other outfitters and/or guide services and for vehicle shuttle services, and accepts and assumes no liability or responsibility whatsoever for any damages, injuries, fatalities, losses, or delays due to any cause whatsoever, whether to person or property in connection with such services and/or arrangements. HDRO shall not be held responsible for any act, omission, or event during the time participants are aboard airlines, trains, buses, vans, or other common carriers or private passenger cars which are not operated by HDRO and each trip member hereby agrees to release HDRO from any and all liability in

connection therewith. Participants are strongly advised to have personal medical insurance, along with baggage and camera insurance. It is understood that if emergency rescue evacuation should become necessary, the expenses are the sole responsibility of the participant and not that of HDRO. HDRO reserves the right to accept or decline service to any person

I understand and agree that such photographs and/or film records may be used for commercial and/or promotional purposes. Rafting Essentials

1. Swimsuit and/or nylon shorts or any type of clothing that dries quickly. We do not recommend cotton clothing.
2. River sandals or old tennis shoes. We don't recommend flip-flops because they are easily lost down the river.
3. Hats, sunscreen, lip balm, sunglasses with a strap
4. Beverages for the raft (Gatorade or water is an excellent choice for Maupin's hot weather, however, we cannot bring glass with us.) Beverages *will* be provided at lunch.
5. If it's really cold, bring fleece or wool clothing layers. **HDRO** will supply splash jackets and wetsuits on cold days.
6. A towel and dry clothing for after your trip. Please leave these items in your cars.
8. Please don't bring anything you are afraid of getting wet or losing on this trip. You may want to leave wedding rings and jewelry behind. **DO NOT BRING CAR KEYS** on the river. You may leave them in our office.
9. We will provide you with a life jacket, paddle and safety equipment. Due to strict laws on the river, guests have to wear a life jacket we provide. You may not bring your own.
10. And finally, please bring your sense of adventure and great attitude! We look forward to rafting with you!

Driving Directions To HDRO Office In Maupin Oregon.

From portland: Take Hwy 26 over Mt Hood toward bend. Turn left onto Hwy 216 east, then turn right on Hwy 197 toward Maupin. The HDRO office is located on Hwy 197 (left hand side) about 500 ft. from the west end of the bridge over the Deschutes river.

From Vancouver areas: Cross the Columbia and Travel East on I 84 to The Dalles. At Exit 87, turn **Right** (South) on **HWY 197: (Bend, Maupin.)** Proceed South on HWY 197 until you reach Maupin. We are on the left.

From Bend: Take Hwy 97 north, then turn left onto Hwy 197 north to Maupin, cross the bridge and we are on the right.
