Pre-order 2014 Oregon Uniform Jury Instructions

Make sure you won't be using obsolete instructions.

The Uniform Civil Jury Instructions Committee has been working on a comprehensive review of all jury instructions last reviewed in 2005 to ensure accuracy. Included in the 2014 supplement will be revised instructions on comparative negligence, causation, apportionment of damages, fraud and the Employer Liability Law. The committee has made revisions to, or updated the comments of, 53 instructions in these and other categories. In addition, the committee has reviewed 95 instructions in various categories and determined that they are still accurate.

The Uniform Criminal Jury Instructions Committee is finishing up its 2014 supplement. One of this year's highlights is a section in the Users' Guide on preservation of instructional error for appellate review. The supplement also contains two new enhancement factor instructions and, as usual, a number of amended instructions, including aggravated harassment, sexual abuse in the second degree and failure to perform the duties of a driver.
