

Changes in Online Access to Oregon Circuit Court Information due to September 14, 2015 Oregon eCourt implementation events

This notice provides specific information about the changes in court operations and on-line access to court information that will occur when circuit courts in Coos, Curry, Hood River, Wasco, Sherman, Gilliam and Wheeler Counties go live with the Odyssey case management system on Monday, September 14, 2015. The effects will last from August 30 to September 28, and will vary depending on the court and the system involved. Appellate court eFiling and information access is not affected.

As used here, “**go-live courts**” refers to the circuit courts in Coos, Curry, Hood River, Wasco, Sherman, Gilliam and Wheeler Counties that will begin using the Odyssey case management system on Monday, September 14.

“**Current Odyssey courts**,” are the 19 circuit courts currently using the Odyssey system (Benton, Clatsop, Columbia, Crook, Deschutes, Douglas, Jackson, Jefferson, Josephine, Klamath, Lake, Lane, Lincoln, Linn, Marion, Multnomah, Polk, Tillamook, and Yamhill). “**OJIN courts**” refers to all other circuit courts, which still are using OJIN.

Court Operations

- All courts will remain open to the public during regular business hours throughout the go-live period.
- Some docket adjustments might occur in current Odyssey courts, particularly on Friday, September 11. Schedule changes will be conveyed to parties by the local court.
- The go-live courts will be operating on reduced docket schedules starting Monday, September 14. Schedule changes will be conveyed to parties by the local court.

Online Access to Court Information and Court Documents

- **In the seven go-live courts:**
 - Remote online access to ‘live’ case register data through OJIN will end at 5:00 p.m. on Tuesday, September 8.
 - OJCIN Online subscribers will continue to have remote online access throughout the go-live period only to OJIN data entered

through September 8. This historical OJIN data for the three go-live courts will remain in OJIN until October 24, 2015.

- Online access to up-to-date data from the go-live courts will resume through the OECI system, after the trial court administrator certifies the accuracy of data migrated into OECI. That certification will occur no later than September 28. If certification occurs earlier, the local court will post a web notice.
- Online access to court calendars for the general public (calendars without links to case data and documents) will be available Wednesday, September 16 at 8 a.m.
- Online access to court calendars for OJCIN subscribers (calendars that contain links to case data and documents) will be available no later than September 28 – if earlier, the local court will post a web notice.
- **In current Odyssey courts:**
 - Remote access to OECI calendars, data and documents will not be available from Friday, September 11 at 12:30 p.m. until Wednesday, September 16 at 8 a.m.
- **In OJIN courts:**
 - Remote online access through OJIN for court calendar and register data from these courts will remain available throughout the go-live period.

Electronic Filing

- **In current Odyssey courts:**
 - eFiling will be available to parties throughout the go-live period, and all statutory timelines and deadlines will remain in effect. Parties will receive e-mail notices containing the time and date that eFiled documents were submitted.
 - Court staff will not be able to accept/reject eFiled documents starting on Friday, September 11, after 12:30 p.m. Staff will resume eFiling reviews on Monday, September 14.
- **In go-live courts:**
 - Permissive eFiling begins on Monday, October 26.
 - Mandatory eFiling for attorneys begins on Monday, December 7.

- **In OJIN courts:**
 - Not available until the court moves to the Odyssey system.

ePayment

- **In go-live courts:**
 - Not available in go-live courts beginning 11:59 p.m. on Sunday, August 30.
 - Payments may be made by calling 888.564.2828 Monday through Friday between 8 a.m. and 4:30 p.m.
 - ePayment resumes on Monday, September 14 at 8 a.m.
- **In current Odyssey courts:**
 - Not available starting at 12:30 p.m. on Friday, September 11.
 - Payments may be made by calling 888.564.2828 Monday through Friday between 8 a.m. and 4:30 p.m.
 - ePayment resumes on Monday, September 14 at 8 a.m.
- **In OJIN courts:**
 - ePayment is available throughout the go-live period.
