Changes in Online Access to Oregon Circuit Court Information due to June 6, 2016 Oregon eCourt Implementation Event

This notice provides specific information about the changes in court operations and on-line access to court information that will occur when the Eastern Oregon Circuit Courts (Baker, Grant, Harney, Malheur, Morrow, Umatilla, Union, Wallowa) go live with the Odyssey case management system on Monday, June 6, 2016. The effects will last from May 27 to June 20, and will vary depending on the court and the service involved. Appellate court eFiling and information access is not affected.

As used here, "**go-live courts**" refers to the Baker, Grant, Harney, Malheur, Morrow, Umatilla, Union, and Wallowa Circuit Courts, which will begin using the Odyssey case management system on Monday, June 6. "**Current Odyssey courts**," are the 28 circuit courts and Tax Court currently using the Odyssey system (Benton, Clackamas, Clatsop, Columbia, Coos, Crook, Curry, Deschutes, Douglas, Gilliam, Hood River, Jackson, Jefferson, Josephine, Klamath, Lake, Lane, Lincoln, Linn, Marion, Multnomah, Polk, Sherman, Tillamook, Wasco, Washington, Wheeler and Yamhill).

Court Operations

- All courts will remain open to the public during regular business hours throughout the go-live period.
- Some docket adjustments might occur in current Odyssey courts, particularly on Friday, June 3. Schedule changes will be conveyed to parties by the local court.
- The go-live courts will be operating on a reduced docket schedule starting Monday, June 6. Schedule changes will be conveyed to parties by the individual court.

Online Access to Court Information and Court Documents

- In the go-live courts:
 - Remote online access to 'live' case register data through OJIN will end at 5:00 p.m. on Tuesday, May 31.
 - OJCIN Online subscribers will continue to have remote online access throughout the go-live period <u>only</u> to OJIN data entered through Tuesday, May 31. This historical OJIN data for the go-live courts will remain in OJIN until July 23, 2016.
 - Online access to up-to-date data from the go-live courts will resume through the OECI system, after the trial court administrator certifies the accuracy of data migrated into OECI. That certification will occur no later than Monday, June 20. If certification occurs earlier, the court will post a web notice.
 - Online access to court calendars for the general public (calendars without links to case data and documents) will be available Wednesday, June 8 at 8 a.m.
 - Online access to court calendars for OJCIN subscribers (calendars that

contain links to case data and documents) will be available no later than Monday, June 20 – if earlier, the individual court will post a web notice.

- In current Odyssey courts:
 - Remote access to OECI calendars, data and documents will not be available from Friday, June 3 at noon until Wednesday, June 8 at 8 a.m.

Electronic Filing

- In the go-live courts:
 - Permissive eFiling begins on Monday, July 18, 2016.
 - Mandatory eFiling for attorneys begins on Monday, August 29.

• In current Odyssey courts:

- eFiling will be available to parties throughout the go-live period, and all statutory timelines and deadlines will remain in effect. Parties will receive e-mail notices containing the time and date that eFiled documents were submitted.
- Court staff will not be able to accept / reject eFiled documents starting on Friday, June 3, after 12:00 p.m. Staff will resume eFiling reviews on Monday, June 6.

<u>ePayment</u>

- In the go-live courts:
 - Not available in the go-live court beginning 11:59 p.m. on Friday, May 27.
 - Payments may be made by calling 888.564.2828 Monday through Friday between 8 a.m. and 4:30 p.m.
 - ePayment resumes on Monday, June 6 at 8 a.m.
- In current Odyssey courts:
 - Not available starting at noon on Friday, June 3.
 - Payments may be made by calling 888.564.2828 Monday through Friday between 8 a.m. and 4:30 p.m.
 - ePayment resumes on Monday, June 3 at 8 a.m.
