There are no exact records of jury trials, bench trials or contested hearings. Typically, 3-4 criminal jury trials are heard on an average each month, 1-2 criminal bench (judge alone) trials, 2-4 civil bench trials, and numerous contested hearings in stalking complaints, restraining orders, domestic relations, criminal cases, and post-conviction, habeas corpus and mandamus proceedings.

19) What attracted you to a judicial career?

I have always had a commitment to public service, and the road to the Judiciary started in 1990 after my Active Duty in the Army as a Judge Advocate when the opportunity arose through the Hermiston Municipal Court.

20) Briefly describe your philosophy of the judicial role, the qualities that are most important for the role, and the greatest challenges to the role.

A fair, impartial and independent judiciary must seek at all times to operate in a manner to insure trust in the court system as essential for the foundation of the rule of law in a democracy. The judge must consider all proceedings as important to all parties to a proceeding, and treat everyone with the respect that all deserve. The court must seek to provide fair, impartial, and legally accurate rulings, adhering to Constitutional and statutory law, all the while maintaining the timely administration of justice, within the limitations and constraints under the Oregon and US Constitution and the statutes established by the legislature and Congress.

21) Briefly describe a case, or a legal issue on which you worked, of which you are particularly proud, or which is reflective of your legal ability, work ethic, judicial philosophy, or temperament.

I regularly review and independently research matters before the court to arrive at accurate legal conclusions, which I usually outline in extensive legal opinions to set forth the legal reasoning behind the judicial decision. The most unique and case of first impression in Oregon is reflected in State v. Watters, 156 P.3d 145, 211 Or. App. 628 (2007)(though the case fails to reflect the trial judge who was myself) (Wallowa County, 2007).

22) Briefly describe an issue, related to Oregon's justice system, that is of particular interest or concern to you, or that you have interest in working toward improving.

All aspects of improving the justice system, usually by addressing processes and procedures that can be used locally and can be pursued at the state level to gain efficiency and adhere to statute.

23) Briefly describe a legal figure, personal, fictional or historical, whom you admire and why.

My admiration goes to two historical figures, President George Washington and President Thomas Jefferson. President Thomas Jefferson must be admired for the drafting of the DECLARATION OF INDEPENDENCE, and President George Washington, who presided over the Constitutional Convention (1787). Through his approach he maintained a watchful eye on the development of the CONSTITUTION, keeping the minds of the delegates fixed on the ideas of self-government and preservation of fundamental human rights. Both along with many others created the legal foundation for our Nation. Without General George Washington, however, we would not likely exist as a separate and independent Nation.
