**I believe a judge must aspire to serve with integrity and intellectual honesty while pursuing just and fair outcomes. The challenge to meeting that lofty goal is be aware of the effect in implicit biases in judicial decision making. In a broader context, a judge should promote equal access to the judicial system and commit to guaranteeing every party the full and fair opportunity to be heard, which is challenged without sufficient judicial resources.**

19) Briefly describe a case, or a legal issue on which you worked, of which you are particularly proud, or which is reflective of your legal ability, work ethic, judicial philosophy, or temperament.

**Every case regardless of the size or nature of claim, or degree of criminal punishment, deserves my full attention and skill as a judge. If in the last trial or hearing I presided over, I followed the letter and spirit of the law; objectively evaluated the evidence; treated the attorneys, parties, and witnesses with dignity and respect; and allowed the parties to be meaningfully heard, then that is the case I am most proud of – regardless of the type or amount of claim.**

20) Briefly describe an issue, related to Oregon's justice system, that is of particular interest or concern to you, or that you have interest in working toward improving.

**The criminal justice system should pursue expanded use of treatment courts. The success of multidisciplinary professional teams to achieve more effective outcomes for defendants with an addiction or mental illness is both practical and well established.**

**The justice system should promote alternative dispute resolution alternatives that are both judicial and non-judicial for family and civil law cases. There are instances when litigation of claims or disputes is not cost effective or productive.**
