I was raised in a blue-collar, working class, immigrant family. My parents had little formal education. All they wanted was for their two children to get a college education and succeed in life. Initially I did not heed their desires, hitting the streets at an early age. By the time I was 17 I had become an automotive machinist / mechanic, and was rolling in the world of drag racing and 4X4 competitions. It was the murder and loss of a close friend and musical mentor that brought me back to college and ultimately to law school.

As I practice in courts across the Pacific Northwest, I have routinely noticed that very few of the judges presiding over cases have the faintest idea of the troubles and issues faced by the immigrants, the working class parties and the victims that stand before them. These are the people who are nearly unrepresented on The Multnomah County Bench. I want to be a judge to bring an understanding of their struggle to the bench and in doing so craft remedies that benefit society, rather then tax it.

Trial Judges need to evenhandedly apply the law, while at the same time keeping in mind fairness and the civil rights of all people. The best trial judges take the bench every workday with the only agenda being to call balls and strikes. This level of professionalism requires a judge to leave behind their politics, bent of their previous area of practice and, in some cases, worldview. It is these ideal philosophical qualities that are both the most important, and the greatest challenges to the role of a trial court judge.
