Prior to becoming a judge I was a trial attorney. I spent five years as a prosecutor in the Lane County District Attorney's Office. During my time in the DA's office I was in court nearly every day. I left the DA's office and spent two and a half years as a civil trial attorney. I appeared in almost all of western Oregon's counties and tried civil cases to juries in Multnomah, Lincoln, Linn, Lane and Jackson counties.

#### I was attracted to a judicial career by the ability to continue to spend time in the courtroom but as a neutral party and not as an advocate.

18) Briefly describe your philosophy of the judicial role, the qualities that are most important for the role, and the greatest challenges to the role.

Being a judge is a job that requires a specific set of skills and a specific temperament. Judges need to be have a broad knowledge of the law in generally combined with the capacity to delve deeply into specific legal areas when the case requires it. A judge must be able to think quickly but not act prematurely. And have the temperament to keep cool when emotions are getting hot and to diffuse volatile situations. Finally, a judge must have an unwavering commitment to being respectfully neutral with everyone.

19) Briefly describe a case, or a legal issue on which you worked, of which you are particularly proud, or which is reflective of your legal ability, work ethic, judicial philosophy, or temperament.

I presided over a jury trial where the defendant was (1) not represented by an attorney, (2) incarcerated in Eastern Oregon and (3) not eligible to be transported to court because the case was civil and not criminal. Traditionally, the defendant would have either not been able to appear at all or participate by telephone. I was able to arrange for the defendant to appear and participate in the trial by simultaneous video transmission. He gave his opening statement, closing argument and questioned witnesses from hundreds of miles away. It was very exciting to use technology to expand who had access to our courts.

20) Briefly describe an issue, related to Oregon's justice system, that is of particular interest or concern to you, or that you have interest in working toward improving.

I am most proud of the work I have been involved with to use technology to broaden access to the courts. I think innovative uses of technology like simultaneous video transmission, e-filing, online court management systems are exciting tools to expand court access. I think insuring that those systems remain agents of excess rather than exclusion

# are some of the most important work the courts will be doing in the next decade.

21) Briefly describe a legal figure (personal, fictional or historical), whom you admire and why.

I've always been a fan of Abraham Lincoln. When I was practicing civil law, I did a lot of traveling to various counties representing people who didn't know much about the legal system. I enjoyed reading about Lincoln's time as a lawyer riding the legal circuit in Illinois and how those lessons informed decisions he made as President.
