**First, the opportunity to make a positive impact on the quality of life in my community, and in particular, those members of the community who are disadvantaged.**

**My philosophy is that judges must work to ensure that every litigant and attorney feels that they were treated fairly and received an adequate opportunity to present pertinent information about their dispute.**

**Additionally, I try to provide litigants a broader perspective about the impact of the litigation, and if appropriate urge and assist the parties**

**to come to an agreement to resolve the dispute. If agreement is not possible, then to work diligently to understand the law related to the dispute and do my best to ensure that it is correctly applied.**

**On a personal level, I always try to remind myself to take our work seriously but not take myself too seriously.**

**The greatest challenge is simply having enough time to manage a docket in a manner that allows enough time to accomplish the above expectations.**

19) Briefly describe a case, or a legal issue on which you worked, of which you are particularly proud, or which is reflective of your legal ability, work ethic, judicial philosophy, or temperament.

**I feel it is better left to others to evaluate this question. However, I am very proud to work with judges around the state that demonstrate a commitment to issues of procedural fairness, community safety, well-being of victims and children and provide encouragement for those individuals that need assistance in making meaningful change in their lives. In particular, the judges who do a significant amount of juvenile work demonstrate the best of those attributes.**
