I concentrate primarily on domestic relations litigation, include divorce, custody and parenting time. I also do adoption, personal injury, restraining orders, and Elderlaw.

The types of cases included Criminal Misdemeanors and Violations, Domestic Relations Litigation, Third-Party Custody, Contested Restraining Orders, Contested Stalking Orders, Probate Litigation, Wrongful Termination, Sexual Harassment, and Elder Abuse.

I have done appeals before the Workers' Compensation Board and the Oregon Court of Appeals.

16) Why do you want to be a judge?

I want to be a judge because I care about my clients and people like them. Washington County is losing experienced judges to retirement and especially judges with family law experience. I want to make sure that people who come before the court feel like they are being heard by someone who understands the issues in the case and who has the maturity, understanding and integrity to make well-reasoned decisions. I know that this newest judicial position in Washington County will be assigned to hear domestic relations and juvenile cases. Based on my life and legal experience, I am the most qualified person currently running for this position. Washington County has judges with criminal law backgrounds and civil law backgrounds. We really need judges with significant family law experience. Eighty percent of family law cases involve at least one litigant who is self-represented. It takes real maturity, experience and understand to handle these challenging cases.

Because of my very broad experience, I am able to take on any assignment on the court, but right now the court needs someone with my domestic relations experience.

17) Briefly describe your philosophy of the judicial role, the qualities that are most important for the role, and the greatest challenges to the role.

Judges are required to promote access to justice. The qualities that are most important for that role include judicial temperament, i.e. maturity, experience, knowledge, compassion, neutrality, and a desire to assure that the court is a place where everyone has the same opportunity to be heard with dignity regardless of their ethnicity, gender, sexual preference or identify, or other bias.

The greatest challenges can be that judges hear from people who are often not at their best since court is not a place where one wants to be as a litigant. One must remember not to add to the stress and anxiety of litigants by falling short on appropriate judicial demeanor. As a judge I would continue to be mindful of providing a courtroom that promotes dignity and respect.

18) Briefly describe a case, or a legal issue on which you worked, of which you are particularly proud, or which is reflective of your legal ability, work ethic, judicial philosophy, or temperament.

I have had many cases that I worked on that I am proud of. I would say that most of them involve children or a vulnerable person. These cases make real differences in people's lives and though they can be difficult, the hard work and pursuit of the law pays off in a positive way most of the time. Many clients have contacted me long after their cases are done with cards and photos with the sentiment that I am a part of their family because I helped to preserve their relationship with their children or helped them through a difficult time. I even had one client, who did not have a lot of money, bring me a polished rock because it reminded him of me. I am very proud of the people I have helped and of their feelings toward me.

19) Briefly describe an issue, related to Oregon's justice system, that concerns you, or that you have interest in working toward improving.

I am concerned that some people feel like they cannot receive a fair hearing or that they are unfairly treated by the system that is not open to feedback. As a qualified woman, simply being elected would go a long way to show people that our court better reflects the community. Having only four women on the court may send a message to women that the court is not an equal place for them. As far as litigants or even attorneys feeling like they are not treated fairly, I would be open to hearing ideas and ways to improve the system while still meeting productivity goals for the court.

20) Briefly describe a legal figure, personal, fictional or historical, whom you admire and why.

I admire former President Barak Obama because he represents true character. He maintained a dignified demeanor and was very thoughtful in his decision making. While I may not have agreed with all of his decisions, I respected and admired him for his compassion, hard work and thoughtful deliberations.

Only four out of fourteen judges currently on the bench in Washington County are women. Our courts should reflect our community. It is time to elect a judge to the bench who has significant domestic relations experience. I have a broad range of legal and life experience and right now is the time for a woman and someone with my experience to fill position 15. It would be a great honor to be the first woman to fill this newest judge position, position 15 in Washington County.
