## Here We Go Again

Governor Kitzhaber's veto of two crucial bills in the fragile budget balancing package submitted to him by the legislature after its grueling third special session triggers yet another round of deliberations for weary legislators. The Governor vetoed Senate Bill 1022 and House Bill 4056. Unless the legislature overrides the vetoes, the result is a reduction in the budget for schools and community colleges of \$317 million. In addition, the \$175 million safety net if revenues continue to fall that House Bill 4056 provides would disappear.

The Governor called the next special session for Friday, August 16, saying it should take only one day for the legislature to decide whether to override his vetoes. If the vetoes are sustained, the Governor has stated that he intends to call yet another special session in early September to ask the legislature to give voters an opportunity to vote for sustainable funding for schools in the November election.

Although the vetoes directly affect school funding, there are no safe harbors if revenues continue to fall. This is especially true for the court system because most legislators have not yet been convinced to give a priority to the resource needs of the judiciary. Stay tuned!

### **Initiative Petitions Update**

On August 5, 2002 the Secretary of State's office announced that measure numbers have been assigned to the initiative petitions that have qualified for the November 5 General Election. Two of the justice system initiatives will be on the ballot. Bill Sizemore's tax initiative #49 and Ted Piccolo's term limits initiative #168 did not qualify for the ballot.

# Justice System Initiatives

- ▶ #67 (Measure 21): Amends Constitution: Revises Procedure For Filling Judicial Vacancies, Electing Judges; Allows Vote For "None Of The Above"
- ▶ #90 (Measure 22): Amends Constitution: Requires Oregon Supreme Court Judges And Court Of Appeals Judges To Be Elected By District

#### **Referrals to Voters**

Measure numbers have been assigned to the two referrals that came out of the third special legislative session. These measures will be voted on in a September 17, 2002, special election.

Measure 19: Amends Constitution: Authorizes Using Education Stability Fund Principal In Specified Circumstances; Transfers \$150 Million To State School Fund; Creates School Capital Matching Subaccount In Stability Fund

**Measure 20:** Increases Cigarette Tax; Uses Revenue For Health Plan, Other Programs.

If voters defeat either of these referrals, or if the next revenue forecast reflects a further budget deficit, there will likely be yet another special session in September.

#### **BOG Resolutions**

At its August 2 meeting, the OSB Board of Governors approved forwarding three resolutions to the House of Delegates for consideration at the HOD annual meeting on October 5.

Two relate to issues that will be before the electorate on the November ballot; the third relates to OSB support in the legislature for indigent defense services.

- 1. BOG recommendation for HOD resolution opposing initiative #67 (Measure 21) that revises the procedure for filling judicial vacancies, electing judges, and allows vote for "None of the Above"
- 2. BOG recommendation for HOD resolution opposing initiative #90 (Measure 22) that requires Oregon Supreme Court and

Court of Appeals judges to be elected by district

3. BOG recommendation for HOD resolution supporting indigent defense services funding



## **Open Court Programs**

The Clackamas County Courthouse is holding an Open Court program on Thursday, August 22. This is the third in a series of courthouse events around the state to encourage a continuing dialog about judicial system issues among lawyers, judges, legislators, and the local community. These events are a joint effort between the OSB and judicial districts.

The purpose of the Open Court program is to invite current and prospective legislators into the court to explore key issues in a county's justice system and to recognize innovative programs. Different presiding judges who participate will customize the program to best meet their local needs.

The Lane County Courthouse has also scheduled an event for Monday, September 9. Talk to your local presiding judge if you are interested in participating in a future open court program in your community.

#### Behind the Scenes...

When you hear about the legislature in the news, you only hear about a legislator, a bill, or a political party. But take a moment to look behind the scenes. There you'll find the committee administrators, legislative staff and lawyers in Legislative Counsel that methodically and conscientiously work to provide legislators the guidance and assistance they need to do their jobs.

Each legislators has personal staff that helps the legislator in his or her office. But it's the work behind the scenes that makes the process of the legislature run smoothly. It's the professional, permanent legislative staff who ensure that the wishes of the legislative committees are followed.

For example, the committee administrators ensures that the committee functions properly. The committee administrator ascertains that background materials are available, that witnesses are lined up, and that agendas are printed. The Publications Center, on the other hand, is the information hub. Employees in the Publications Center ensure that the bills and amendments are printed and available so that the legislators, lobbyists, and staff can do their work.

The 13 staff employed in Legislative Counsel's office are responsible for putting concepts into proper legislative format and drafting bills. The goal is to assure that all measures that pass are legally and technically correct. The staff prepared 3,779 bill drafts for the 2001 session, not to mention 5,133 amendments to those drafts. And, remember, a bill draft can be as short as a one-pager or a rewrite of the tax code.

All this and more goes on behind the scenes. You won't see the staff in the legislature come out to take a bow. But, as in many productions, the real drama is behind the curtain.
