### **Court Budget Reductions**

On October 28, 2002, Oregon Supreme Court Chief Justice Wallace Carson, Jr., announced his preliminary plan for implementing significant budget reductions to Oregon's court system. As a result of the fifth special legislative session, the court budget was reduced an additional \$13.6 million, including \$8 million in court operations alone.

As the September 20, 2002, issue of the *Capitol Insider* stated, the potential \$8 million reduction to the operations budget, if taken over the five months remaining in the biennium (if Ballot Measure 28, the three-year tax increase, fails on January 28, 2003) results in a 25% cut to funds available for reduction. Because the majority of the operations budget funds people, a corresponding reduction in staff support for the operation of the court would be required.

Elements of the plan include:

**Court closures**. All appellate, tax, and circuit courts statewide will close to the public on Fridays between March 1 and June 30, 2003.

**Staff reductions and layoffs**. Each court will reduce staff work hours by 10 percent, reduce expenditures, and implement layoffs to meet targeted cut levels. Each local court is working on a plan to submit to the State Court Administrator for review. Local layoff numbers will be available thereafter.

#### Delayed and/or "no action" processing of

**cases**. All circuit courts statewide will stop processing small claims and non-person misdemeanor cases.\* Cases can be filed, but no action will be taken on them between March 1 and June 30, 2003. The processing of all other case types will be pared back and all processing slowed considerably due to the loss of staff. \* In December 2001, the courts established a list of priority case types. Violent felonies are at the top of the priority list (i.e., the last to be cut); small claims and non-person misdemeanors are at the bottom of the list. The priority list is:

- 1 Person-to-person felonies adult and juvenile (Measure 11 crimes, e.g., murder)
- 2 Juvenile permanency matters (termination of parental rights; dependency)
- 3 Family Abuse Protection Act/Elder Abuse Protection Act orders; juvenile restraining orders
- 4 Person-to-person misdemeanors adult and juvenile (e.g., Driving Under the Influence of Intoxicants (DUII))
- 5 Integrated family/drug court docket
- 6 Child-connected domestic relations and adoptions
- 7 Civil commitment and guardianship
- 8 Other specialized docket programs (e.g., domestic violence, DUII, mental health "courts")
- 9 Non-person felonies (e.g., burglary, theft)
- 10 ADR program coordination (mediation and arbitration)
- 11 Civil (all levels)
- 12 Pro se assistance programs
- 13 Property-only domestic relations
- 14 Forcible entry and detainer (landlord/tenant cases)
- 15 Probate, with contested cases as the priority
- 16 Violations (urban/neighborhood speeding and other high-safety violations are priorities)
- 17 Non-person misdemeanors adult and juvenile (e.g., shoplifting, animal abuse)
- 18 Small claims (citizens with disputes up to \$5,000)

#### **December Revenue Forecast**

The State's Office of Economic Analysis released its December 2002 State General Fund revenue forecast in late November. It reflects the sixth straight quarterly decline in revenue projections for the 2001-2003 biennium. General fund revenue is \$133 million less than was estimated in September 2002. These expected losses were partially offset by increased lottery revenues of \$7 million. As a result, the state is looking at an additional budget shortfall of about \$126 million. State government revenue has dropped more than \$1.8 billion since the legislature adopted the 2001-2003 budget in July 2001.

If voters reject the three-year income tax increase (Ballot Measure 28) in the January 28, 2003 special election, legislators must tackle a budget shortfall for the remaining five months of the 2001-2003 biennium of about \$436 million when the 2003 legislative session begins on January 13, 2003.

We are pleased to report that the 2003 Legislature will include 16 legislators who are lawyers or have legal training. There were even a couple of legislative races that pitted two candidates with legal training against each other. Senate District 17 offered voters a choice between Democratic Representative Charlie Ringo and Republican Representative Bill Witt, with Representative Ringo claiming victory after a gracious concession from Representative Witt. The race for House District 38 came down to the wire, offering a choice between Republican Jim Zupancic and Democrat Greg Macpherson, with Macpherson edging out Zupancic.

The OSB is grateful to have many friends in the legislature, but it is also important to our profession to have law-trained legislators. These legislators understand the needs of the judicial system, and how proposed legislation affects our profession and the clients we serve.

House speaker-elect Karen Minnis announced the committees and chairs for the 2003 session in the House today. Rep. Max Williams, a strong supporter of the bar justice system issues, has been named House Judiciary Committee Chair.

#### **Gubernatorial Race Results**

The race between Democrat Ted Kulongoski and Republican Kevin Mannix was close. Both candidates are experienced lawyers, and strong supporters of the OSB, with an appreciation of the issues facing the judicial system. Ultimately, Governor-elect Kulongoski will take the helm in January. However, Kevin Mannix assured the voters that he intends to remain engaged in public affairs.

Meanwhile, Governor-elect Kulongoski is busy putting together his staff. Peter Bragdon, a Portland lawyer, will be his chief of staff. And Governor-elect Kulongoski announced five new staff appointments on December 12, including three Oregon lawyers. Pat Egan, Governor Kitzhaber's chief legislative liaison, will hold a similar job in Governor-elect Kulongoski's administration. MardiLyn Saathoff is a lawyer with Tektronix and will become Governor-elect Kulongoski's legal counsel. Stephen Schneider will become deputy chief of staff.

#### **Gleaves Committee Report**

The Joint Committee on Trial Court Judicial Resources, chaired by Eugene lawyer Vernon D. Gleaves, submitted its Report of the 2002-2003 Joint Committee on Oregon Trial Court Judicial Resources to the Honorable Wallace P. Carson, Jr., Chief Justice of the Oregon Supreme Court, and Angel Lopez, President of the Oregon State Bar, on November 15, 2002.

The Committee considered requests for 13 judicial positions plus funding for 5.8 full-time equivalent pro tem judges and 6.3 referees. The principal factor considered in evaluating the requests was a weighted caseload study of the Oregon trial courts conducted by the National Center for State Courts dated July 22, 2000, and updated based upon 2001 case filings.

The Committee recommended that elected full-time judges or pro tem funding for judges and adequate staff for 14.8 full-time equivalent positions (9 full-time judicial positions and 5.8 full-time equivalent pro tem judges) plus funding for 6.3 referees be approved and provided for by the 2003 Legislature. The priority ranking for the recommended 9 full-time judicial positions is as follows:

#### Interim Judiciary Committee

The Joint Interim Judiciary Committee met on December 4, 2002. The pre-session filing of legislative proposals from the OSB and other interest groups filled the morning agenda. The Committee approved for presession filing and introduction in the 2003 Legislature 30 law improvement proposals presented by the OSB.

At press time, Senate and House bill numbers are being assigned to the OSB proposals.

The 2003 Legislature is scheduled to convene on January 13, 2003. The opportunity to pre-session file the OSB law improvement proposals is provided courtesy of the Joint Interim Judiciary Committee. It allows the OSB proposals to be set for hearings early in the upcoming session. Given the gravity of the budget issues that the legislature will be tackling this session, it important for the legislature to consider our proposals as early as possible during the session.

Following is the list of OSB section and committee legislative proposals that have been pre-session filed. We have included the House and Senate Bill numbers if assigned.
