¹ I find my ignorance somewhat "amusing." I was at a Stoll, Berne party a couple of years ago and was talking with Tom Balmer, with whom I had had a case several years before. He said he was reading a brief I had written. I asked why. He said he was interested in the case. (At the time it was pending before the Oregon Supreme Court, and oral arguments were scheduled.) I asked him why. He said he served on that court. I apologized and explained that I was not very politically involved. I later found out that he was the Chief Justice. (He is a really great fellow and seems to be an excellent Chief Justice. That was how I remembered him in private practice, too.)

Approx. 1974-1976 On two occasions I graded Bar Exams, first for O. Meredith Wilson and then for Ron Marceau. It could have been a few years later.

1985-Present Sole practitioner primarily engaged in trial work, mostly at the state level, but some at the federal level. Practice has been very wide ranging and has included appellate work

Several years ago I edited a CLE Insurance Law chapter on sureties. I recently served on the Yamhill County/Washington County LPRC. As I recall, each appointment was for a year, with a designated number of reappointments. During that period of time I oversaw two investigations and wrote two reports.

As a sole practitioner I have been able to devote time to some business interests, primarily in real estate. As a result of representing a very small, local minority bank (American State Bank), I manage its remnants for the benefit of the founder's wife and ex-wife. That has resulted in my overseeing the loaning of money to the real estate construction industry and some other small enterprises.

The primary question is whether my skill sets would be helpful. I know almost nothing about any specific issues that may be upcoming, in addition to the basic budgetary ones. I have no motivation to add to my sparse resume, meaning I see no "prestige" in being a member of the BOG.

Some of the members of the BOG may know me. If so, that would probably be a better source of insight than anything I might say. I think I am a pretty quick study, I spend the time to read materials and I have had wide ranging interests that might bring different perspectives to bear.
