## Oregon State Bar Meeting of the Board of Governors

March 4, 2005 Special Open Session Minutes

- A. Waiver One Meeting Notice Requirement
  - 1. Section 18.6 Suspension of Service of Member of the Board of Governors, Local Professional Responsibility Committees, and State Professional Responsibility Board While Formal Disciplinary Proceedings are Pending Against the Member; Appointment of Temporary Replacement for Suspended Board of Governors Member

Mark Comstock, chair of the Policy and Governance Committee, presented information concerning the committee's efforts to propose an amendment to Bar Bylaw 18.6 in order to deal with selecting a temporary replacement for a board member suspended under the bylaw. Mr. Browning, House of Delegates member from Region 4, offered input from the region, including its belief: (1) no real vacancy exists because Mr. Paulson is suspended, yet not removed from the board; (2) the board has no authority to appointment a BOG member for Region 4; and (3) the region should have the opportunity to recall its board member and in the event the region elects not to recall, the region should remain without board member representation.

The Policy and Governance Committee has prepared a draft amendment to Bar Bylaw 18.6 for the board's review at it April 8, 2005 meeting. This meeting will satisfy the one meeting notice requirement regarding that proposal.
