Oregon law is dominated by legislation and administrative rules. At last count, the Oregon Revised Statutes comprised over 12,500 pages regulating nearly every imaginable corner of public and private life, from abandoned boats to zoning and zoos. An estimated 65% to 75% of all cases in the Oregon Supreme Court and Oregon Court of Appeals involve the interpretation of a statute, rule, or constitutional provision. This means that the practice of law today consists largely of interpreting and applying those statutes and administrative rules.

The question of interpretation does not start at the appellate level. It first becomes an issue in the trial court or administrative hearing. Edited by Judge Jack Landau, an expert in statutory interpretation, this publication will guide you through the *PGE* statutory construction analysis, as recently modified by *Gaines*, so that you will be prepared to effectively argue your case at trial and on appeal.
