The Uniform Civil Jury Instructions Committee has written 16 new instructions on evidence and witnesses, admissions, landlord-tenant, and employment discrimination. It has also revised eight instructions, including precautionary, witness false in part, possessor's duty to invitee, noneconomic damages, and a verdict form.
