The Uniform Civil Jury Instructions Committee has been working on a comprehensive review of all jury instructions last reviewed in 2005 to ensure accuracy. Included in the 2014 supplement will be revised instructions on comparative negligence, causation, apportionment of damages, fraud, and the Employer Liability Law. The committee has made revisions to, or updated the comments of, 53 instructions in these and other categories. In addition, the committee has reviewed 95 instructions in various categories and determined that they are still accurate.
