Requirement/Application Process:

- Determine your eligibility. (See page 2 for eligibility rules)
- If you are eligible, you must contact the Washington State Bar Association (WSBA) for the reciprocity admission application or access the online application at http://www.wsba.org/lawyers/licensing/reciprocity_requirements.htm.
- Complete the application and submit it to the WSBA along with a check for the fee of \$870.00, no later than September 18, 2009.
- Submit the CLE registration form (page 4) along with \$275 to the Oregon State Bar no later than September 18, 2009. Space is limited to the first 40 registrants.
- Make your own hotel accommodations if necessary.
- Attend the seminar on October 17 & 18, 2009.

For your convenience, a special room rate of \$88.00/night has been arranged at the Holiday Inn Express in Tigard. The Holiday Inn Express is located at 15700 SW Upper Boones Ferry Rd, less than one mile from the Oregon State Bar Center. Call the Holiday Inn to reserve your room at 503-620-2980, make sure to mention this program to receive the special rate.

WASHINGTON RECIPROCITY RULES

Oregon passed a reciprocity rule (Oregon Rule 15.05) that made it possible for those who have not taken the Oregon bar exam to gain admission to the Oregon State Bar. Washington has also made it possible for Oregon attorneys to be admitted in Washington without passing the Washington bar exam (Washington Admission to Practice Rule 18).

Requirements for Admission under APR 18

All applicants should read APR 18 for all the admission requirements under that rule. In summary, to apply for admission under APR 18, an applicant must meet the following requirements:

- Present satisfactory proof of both admission to the practice of law with current good standing in another state or territory of the United States or the District of Columbia, and active legal experience as a lawyer or counselor at law at the time of the application
- Have been engaged in the active practice of law for no less than three of the four years immediately preceding the application for admission
- Be a graduate of and ABA accredited law school
- Have sat for and passed the Oregon State Bar Exam
- Complete such application fees and costs as the Washington Bar Association establishes
- Complete 15 hours of CLE credit: 2 hours ethics, 4 hours civil procedure, and 9 elective subjects on Washington substantive law
- Possess the good moral character and fitness requisite for a member of the Bar of the State of Washington
- Pay all required fees

In the event that you determine that you are eligible and you proceed with the application and CLE course, the great news is that this CLE will satisfy all of the CLE credit requirements to get reciprocal admission to the Washington State Bar Association.
