Oregon New Lawyers Division (ONLD) emails — ONLD events are invaluable to any student preparing themselves for a career in the legal profession. You will receive emails regarding Continuing Legal Education (CLE) programs (most are free for students), panels, and social events geared towards new lawyers. Networking with new lawyers and making connections at these events is helpful for all law students. By returning this form, you will automatically be included in the ONLD email list. OSB Section membership — Joining an OSB Section offers you a chance to explore an area of law before being admitted to the bar, and many sections offer complimentary membership to law students. As a law student section member, you will receive email notices for the section's upcoming events and programs, be added to its list serve (when available), and receive its publications. Students may join sections through October 31, for the remainder of the year. Please note, section membership fees are based on a calendar year, and cannot be prorated.

OSB *Bulletin* **delivered to your home** — The OSB's monthly magazine includes opinion pieces of Oregon lawyers, practice-oriented articles, ads, and bar news. A one-year subscription is only \$10 if you join the LSA Program. You do not need to purchase the OSB *Bulletin* to join a bar section or vice versa.
