### Oregon New Lawyers Division (ONLD) emails

ONLD events are invaluable to any student preparing themselves for a career in the legal profession. You will receive emails regarding Continuing Legal Education (CLE) programs (most are free for students), panels, and social events specifically geared towards new lawyers. Networking with new lawyers and making connections at these events is helpful for all law students.

### OSB Section membership.
