This panel will discuss the ongoing issues of cannabis prohibition in Oregon, despite the creation and development of the commercial cannabis marketplace in Oregon. Despite "legalization" of cannabis for adult-use in Oregon, the shadow of prohibition remains, affecting institutional policies and practices that continue to disproportionately impact the daily lives of Oregonians. Panelists will discuss relevant cannabis criminal statistics, history of cannabis prohibition and its connection with the militarization and tactics of police and rise of police misconduct; cannabis prosecutions in state and federal court; canna-bigotry and other cannabis discrimination, and the legislative efforts to bring equity to the commercial cannabis marketplace.
