Courtney Dippel is Assistant Disciplinary Counsel -Litigation for the Oregon State Bar and believes the best trial lawyers are outstanding storytellers. In her current role, Courtney represents the Bar in formal disciplinary proceedings against lawyers for violations of the Rules of Professional Conduct. Prior to joining the Bar, Courtney spent her career in private practice and gained experience in a wide variety of litigation matters in both state and federal courts and private arbitrations, including cases involving business torts, commercial contracts, the Uniform Commercial Code, real estate litigation, lender liability, fiduciary liability, fraud, commercial foreclosures, receiverships, trade secrets, employment discrimination and professional malpractice. For the last eight years. Courtney's practice focused on representing plaintiffs in legal malpractice cases and related disputes.

Courtney was previously the Secretary for the Oregon State Bar Client Security Fund and the former Chair of the Bar's Procedure and Practice Committee. As Chair of the Procedure and Practice Committee, Courtney was responsible for coordinating the Committee's comments on proposed legislation, testifying in front of the Oregon State legislature in support of specific bills, and proposing changes in the law for the way lawyers practice.
