12 This Court having previously signed an Order of Default Against Defendant Arthur
13 P. Klosterman and Permanent Injunction,

14 IT IS HEREBY ORDERED that judgment be entered in favor of Plaintiff Oregon State Bar
15 and against Defendant Arthur P. Klosterman, and that Defendant Arthur P. Klosterman
16 shall be, and is hereby, permanently enjoined from practicing law, including:

17 1. Enjoined from any personal contact with any persons in the nature of
18 consultation, explanation, recommendation, or advice regarding their legal matters.

19 2. Enjoined from meeting with any persons to discuss their individual
20 circumstances relating to their need or desire for legal forms, legal services or legal
21 assistance.

22 3. Enjoined from obtaining information orally, in writing, or in any other
23 manner relating to individual facts and circumstances so as to assist any persons with their
24 legal matters.

25 4. Enjoined from advising any persons regarding their eligibility for or
26 advisability of legal remedies to address any person's particular legal matters.

1 5. Enjoined from advising any persons regarding procedural functions of the
2 court system as it relates to any person's particular legal matters including advice
3 regarding jurisdiction or venue.

4 6. Enjoined from assisting in selecting particular forms, documents or pleadings
5 for any persons to address their legal matters.

6 7. Enjoined from assisting in any way with the preparation or filling out of legal
7 forms, or any parts of such forms, documents or pleadings for any persons.

8 8. Enjoined from assisting, suggesting or advising any persons how forms,
9 documents or pleadings should be used to address or to solve particular legal problems.

10 9. Enjoined from representing to the public in any manner that he is authorized
11 to practice law.

12 10. Enjoined from using print or electronic materials, advertisements, telephonic
13 voice messages or other solicitations describing services, which can reasonably be
14 construed as legal services, including, but not limited to, the use of "Attorney at Law" on
15 all letterhead, business cards, and advertisements, and the use of
16 "salemattorney@juno.com" as an email contact.

17 11. Enjoined from taking any action for another which requires legal skill or
18 judgment.

19 12. Nothing included in this Judgment and Decree precludes Defendant
20 Klosterman from working for someone authorized to practice so long as he is acting within
21 the course of his duties and under the direction and supervision of an individual
22 authorized to practice law.

23 13. The Court also hereby awards Plaintiff its reasonable attorney fees, in the total
24 sum of \$1,651.20, and costs and disbursements in the total sum of \$310.00, and post
25 judgment simple interest accruing on these sums at the legal rate 9.00% per annum from
26 date of entry of judgment.


