DEFAULT JUDGMENT
AND DECREE

This matter came before this court on the motion of plaintiff for an order of default and default judgment and decree against defendant, Andras Janos Nagy. It appearing from the records that defendant was duly served with summons and complaint in Multnomah County, Oregon, on May 28, 1997, and that defendant has not answered nor made any appearance herein, although the time provided therefor has expired; and

It further appearing that defendant was not at the time of service on him, nor is he now, in the military service of the United States, a minor, or an incapacitated person; and

The court having entered an order of default against defendant and finding generally in favor of plaintiff and against defendant on plaintiff's complaint; Now, Therefore,

IT IS HEREBY ORDERED AND ADJUDGED that defendant, Andras Janos Nagy, is permanently enjoined, either directly or by or through any business or subsidiary he may own or operate, from engaging in the

1 practice of law, including but not limited to:

- 2 (a) Advising the use of revocable living trusts as estate planning
3 devices;
- 4 (b) Selecting and completing forms of revocable living trusts and
5 amendments thereto or drafting such documents;
- 6 (c) Selecting and completing last will and testaments or drafting
7 such wills in connection with performing estate planning
8 services;
- 9 (d) Selecting and completing real estate deed forms and other
10 conveyances or drafting such deeds and conveyances;
- 11 (e) Selecting and completing durable powers of attorney or
12 drafting such powers of attorney in connection with performing
13 estate planning services;
- 14 (f) Giving tax advice;
- 15 (g) Acting in an advisory capacity and recommending or designing
16 revocable living trust and real property conveyances;
- 17 (h) Giving advice about estate planning, revocable living trusts
18 or property transfers that involves the application of legal
19 principles to individual circumstances; and

20 IT IS FURTHER ORDERED AND ADJUDGED that defendant, Andras
21 Janos Nagy, is permanently enjoined, either directly or by or
22 through any business or subsidiary he may own or operate, from
23 otherwise engaging in the practice of law in violation of ORS
24 9.160; and

25 IT IS FURTHER ORDERED AND ADJUDGED that plaintiff have
26 judgment for its costs and disbursements.
