## Having a Dog in the Fight: Animal-related Crimes and Defenses

Jacob Kamins, the nation's only deputy district attorney dedicated to prosecuting animal crimes statewide, and Geordie Duckler, an attorney known nationally for his work with animal-related legal issues, will team up to examine the current state of major animal cruelty laws in Oregon, including relevant case law and current trends. Using a hypothetical fact pattern, Kamins and Duckler will discuss: prosecution and defense strategies; potential defendants; what constitutes minimum care; and medical care distinctions with regard to animals and people. Animal personality and characteristics will be explored in relation to lawful and unlawful behavior, and the differences between crimes and code violations will be reviewed. Collateral issues include forfeiture and post-conviction restrictions for defendants and a discussion about victims' rights.
