**I've received mediator training from the Oregon Department of Justice. As a Marion County Circuit Court Judge Pro Tem, a fair amount of time was spent mediating between litigants. I mediated Forcible Entry and Detainer (Eviction) cases often.**

I officiated hundreds of weddings for Marion County citizens. I issued search warrants and arrest warrants.**

**I also spent 5 years as an Administrative Law Judge for the State of Oregon presiding over thousands of cases, including complex securities cases, environmental cases, and licensing cases.**

16) Why do you want to be a judge?

**Public service is important to me. I've devoted my professional life to public service and over 1/3 of in a judicial role (7 years) with the State of Oregon, including the Marion County Circuit Court. Judicial work is the work I am built for and am meant to do – it's my passion, and the best way I can continue to serve the people of my community.**

17) Briefly describe your philosophy of the judicial role, the qualities that are most important for the role, and the greatest challenges to the role.

**As a prosecutor, my goal was always to do justice. I was guided by the constitution and the principles of law, and I did not hesitate to dismiss a case if the evidence did not support the charge. I brought these same principles with me to the Marion County Circuit Court.**

**A judge is in the customer service business. People come before a judge to get justice, and it's the judge's job to treat them with dignity and respect, to listen to them, to set aside any bias or preconceived ideas, to get to the truth of the matter, and to deliver the right result – justice. A good judge provides good customer service.**

**The issues that come before a judge aren't always - in the grand scheme of things - the most important. However, when I was a judge, I treated each of the issues I heard like they were the most important because to the people before me, they were. I know what it's like not to get justice - I've experienced it personally, I've seen it happen to my family, and I've seen it happen to clients. If I'm elected, it will never let it happen in my courtroom.**

**Whether the case involves an indigent criminal defendant or a sophisticated business, I will always be fair and just; I will always treat attorneys and clients with dignity and respect; I will always be prepared and give thoughtful consideration to the arguments before me; I will always explain my rulings no matter how "big" or "small" the issue or case is; and I will always make decisions based on the facts before me, the law, and the Constitution. My personal opinions and beliefs will never control my decisions, and I will always remember that there is a person, a family, or a person's livelihood at the heart of every case.**

**Some of the cases that came before me when I was on the bench at the Marion County Circuit Court were quite frankly heartbreaking. It's hard not to take these cases home with you at night. This is what I found most challenging about being a judge.**

18) Briefly describe a case, or a legal issue on which you worked, of which you are particularly proud, or which is reflective of your legal ability, work ethic, judicial philosophy, or temperament.

**I recently led a project that will result in the receipt of over \$270 million from the federal government over five years to lower insurance premiums for hundreds of thousands of Oregonians who purchase their own health insurance.**

**I'm a problem solver and am always looking for better ways to do things. When I was on the Marion County Circuit Court, I developed the traffic diversion program currently in place. I also made a number of process improvements that sped up the disposition of motions.**

**In addition to increasing judicial efficiency, I'm interested in exploring creative sentencing and alternatives to incarceration for non-violent crimes and expanding the use of treatment and mental health courts.**

Perhaps even more important than the extensive, traditional legal experience that I bring to the table, is the unmatched government and legislative expertise I possess.**

**Because the state capital is in our county, we see a lot of cases that other courts do not. Having a judge who understands how government works, who has written and shepherded laws from pen to paper all the way to the Governor's desk and through implementation is essential. We need someone who has worked on issues that impact the entire state and citizenry of Oregon.**

## **Personal Life**

**I'm far from your stereotypical judge, prosecutor, or attorney. I grew up in a violent household. I was the son of a single mother who lived with an abusive man. As a child, I witnessed and experienced abuse and violence that no one should. I watched my mother spiral into depression, alcoholism, and drug addiction and saw her ultimately die of a heroin overdose.**

**Having grown up under these circumstances, I have a unique perspective on the opioid epidemic, children of drug addicted parents, mental illness, and domestic violence – significant issues plaguing our community. I understand addiction, depression, codependency, and what it's like to be a victim. I can readily empathize with victims and those struggling with alcohol and drug addiction and can show compassion when it's needed.**

**I think you can tell a lot about a person by his or her spouse and children. I've been married to my wife, Emily, a few months short of 20 years. She's the sweetest person in the world. She works at Stayton High School and is beloved by students and teachers alike. In fact, this year she won the district's annual Above and Beyond award for (you guessed it) going above and beyond what is required. My son, Henry is a sophomore at Stayton High School. He's a lot like his mother, in that he too is well-liked by both students and teachers. He's a hard-worker and is a straight-A student in the honors program.
