**I have been a full time Clatsop County Circuit Court Judge since January, 2007. Prior to that, I served as a Municipal Court Judge since approximately 2007 (both as a pro-tem judge and a sitting Municipal Court Judge), presiding over an assortment of matters brought before the court including arraignments, traffic violations, misdemeanors, and municipal code violations. From approximately 2000 through 2006, I served as a local Land Use Hearings Officer and presided over an assortment of land use requests, including conditional use permits, variances and appeals from planning director determinations.**

11) Describe the general character of your judicial work over the past five years. Indicate the nature of the cases over which you preside, any specialty courts or court programs, and any legal areas in which you concentrate.

**My judicial work consists of a variety of all cases filed in circuit court – ranging from criminal cases of all levels to civil litigation including: probate, guardianships, civil commitment hearings, dissolution cases, support enforcement, small claims and landlord tenant disputes. Since 2009, I have presided over the Clatsop County Treatment (Mental Health) Court.**

**Before becoming a full-time judge, I participated in various aspects of the legal system, including the role of prosecutor, defender, attorney, advocate**

**and judge. I enjoy the challenge and I believe I have the skills to provide a fair and impartial review of matters in dispute and to provide the litigants a respectful forum for resolution.**

20) Briefly describe your philosophy of the judicial role, the qualities that are most important for the role, and the greatest challenges to the role.

**It remains my philosophy that an effective judge must be a good listener, must follow the law, must treat those who come before the court with respect, must be consistent and even-tempered.**

**In my view, no matter is small or insignificant. Each person who comes before the court deserves undivided attention and should leave the courtroom believing that, regardless of the outcome, the process was thorough and fair and that each litigant was afforded full consideration.**

21) Briefly describe a case, or a legal issue on which you worked, of which you are particularly proud, or which is reflective of your legal ability, work ethic, judicial philosophy, or temperament.

**I am very proud of establishing our Clatsop County Treatment (Mental Health) Court. In sum, we provide an alternative to traditional probation supervision. The participants meet weekly with the court and Treatment Court Team. Each participant has a personalized treatment and probation plan including ongoing opportunities for intervention, support, incentives or sanctions. Graduates of the program have successfully participated in treatment, have fulfilled their probation sentence requirements, have demonstrated stability of mental health or behavioral issues, have documented extended sobriety and have independently implemented an ongoing plan for continued success.**

22) Briefly describe an issue, related to Oregon's justice system, that is of particular interest or concern to you, or that you have interest in working toward improving.

**As above, continuing to find appropriate avenues for handling the mentally ill who find themselves in the criminal justice system because of criminal behavior.**

**During my early years of practice, I appeared before a number of judges with differing demeanors and approaches to the role of judge. Those who**

**impressed me in a positive manner were plain-spoken, unpretentious and conveyed, by their sincere and common-sense approach, that they were genuinely concerned about each person and each issue brought before them. I strive to be this kind of judge.**
