

## **2025 MCLE Reporting Instructions for Out-Of-State Attorney Members of RECIPROCAL STATE BARS (WA, ID, UT)**

- Although your practice is located in Washington, Idaho or Utah, you are required to complete your Oregon MCLE requirements. **If you are in compliance with the MCLE requirements in WA, ID or UT, you can comply with your MCLE requirements in Oregon by:**
  1. **Uploading your Comity Certificate of MCLE Compliance in WA, ID or UT;  
*PLUS***
  2. **Posting the 1.0 required Oregon abuse reporting credit to your Oregon MCLE transcript**
- All required **credits must be completed by midnight on April 30, 2025**.
- Your completed compliance report must be **electronically certified and submitted by midnight on June 2, 2025**.
  - Note: our submission deadline is typically May 31st. However, in accordance with our MCLE Regulations, if May 31 is a Saturday or legal holiday, including Sunday, or a day that the Oregon State Bar office is closed, the due date shall be the next regular business day. Accordingly, the deadline for 2025 is Monday, June 2nd.

### **To view your MCLE transcript:**

1. Log on to your [Member Dashboard](#) on the bar website
2. Click the “MCLE Reporting” tab
3. Click the “MCLE Transcript” button.

Review your transcript and make any necessary deletions or edits using the “Edit” and “Delete” buttons.

If your transcript is incomplete, complete the required credits and add them to your transcript by clicking the “Add Activity to Transcript” button. **Please add all categories of CLE activities to your transcript, including your Comity Certificate and your abuse reporting credit.** We will not accept paper or email addendums to MCLE reports.

**To submit your MCLE transcript:**

Once you have met your minimum CLE requirements, you will be prompted, at the bottom of your transcript, to **electronically certify and submit your report.**

**To submit your MCLE transcript:**

Once you have met your minimum CLE requirements, the box at the top of your transcript will turn green. You will see the message below. Please press “submit report.” **Your report is not submitted until you have pressed submit report.**

**WARNING:** When you submit your report, your carry over credit will be calculated and you will not be able to add additional credits. If you would like to complete additional credits to carry over to your next reporting cycle, do not submit your report until you have completed and entered those credits.

Submit Report

If you see the box below, you have not met your requirements and cannot submit your report. To find what is missing, scroll to the bottom of your transcript. Anything in red below has not been met.

Your administrator can make changes to your report for you, but attorneys must personally review, certify and submit their compliance report by June 2, 2025.
